

- 4- Top dressing of entire lawn with proportionate quantity of garden soil, manure fertilizer, pesticides etc twice a year to make the lawn healthy, grassy green and dressing free trimming considering shape of all hedges
- 5- Empty all garbage containers including cleaning of the surrounding area collecting the garbage from the garbage box
- 6- Construct compost pit at site and use for dumping garbage
